



2022 Convention Payment Plan Agreement

You **MUST** initial each section and sign and date the bottom of this form before you can be allowed access to complete your downpayment for FLOAT 2022.

___ I agree to make a one time payment of \$150.00 US plus an additional fee of \$9.00 US that goes to cover the cost of the online registration system. I understand that this fee of \$159.00 US is completely NON-REFUNDABLE. I agree that this initial payment of \$159.00 US will be considered an application fee, and will be put towards either my registration fee for FLOAT 2022 or towards my cancellation fee should I choose not to attend FLOAT 2022 for any reason. I also understand that the \$9.00 fee collected for the online registration system is a separate fee and not to be added to my FLOAT 2022 balance due.

___ I understand that by making this payment of \$150 US plus \$9 US, I am enrolled in a payment program for FLOAT 2022 at a convention rate of \$549.00 US

___ I understand that in accordance with this agreement, I **MUST** complete all payments of my registration fee on or before November 1, 2021, in order to secure my spot for FLOAT 2022 UNLESS FLOAT has to put a COVID attendance restriction on the event. If that occurs, I understand that my spot may be forfeit if I have not completed my payments before November 1, 2021, because of attendance restrictions.

___ I understand and agree that if I fail to complete my payment series by the deadline, based on COVID conditions listed above, my reservation for FLOAT 2022 will be cancelled.

___ I understand that until my registration fee is completed in full for FLOAT 2022, I cannot purchase or enroll in any optional classes or upgrades for the convention. This includes master classes, bonus classes, full day programs, the FLOATation Pass and more. I AGREE THAT I AM NOT OFFICIALLY REGISTERED FOR FLOAT 2022 UNTIL MY REGISTRATION FEE IS PAID IN FULL.

___ In the event that FLOAT 2022 has to be rescheduled or postponed for any reason, I understand and agree that my registration fee will move with me to the new date and will not be subject to a refund simply because of the change of dates.

___ I understand that there is a possibility, however remote, that FLOAT may have to put in place social distancing guidelines and MAY require the wearing of masks by all attendees at the convention. By enrolling in this program, I both understand and agree to the fact that I may have to wear a face mask while attending any portion of the convention. I also understand that if I fail to honor this policy should it need to be put in place, the producers have the right to remove me from the convention for the health and safety of others in attendance.
