

**PLEASE READ ALL THE INFORMATION BELOW BEFORE REGISTERING FOR ACADEMIC ACCESS AT FLOAT USING OUR PAYMENT PLAN:**

1. In order to enroll in the program, you must make a NON-REFUNDABLE initial payment of \$295 plus a \$29 service charge, equalling \$324 US. Again, this payment is NON-REFUNDABLE and will not be returned to you under any circumstances once you enroll. You must be enrolled in the program on or before July 31st, 2025, in order to participate.
2. Over the course of the next five (5) months, your credit card will be charged a fee of \$100.00 each month. This will amount to the total charge of \$824 US, which includes the service fee previously mentioned.
3. Upon completion of the six (6) payments, you will receive special instructions as to how to formerly register for FLOAT at that time. You will not receive any formal registration information or access to the discounted hotel room rate at FLOAT until your payment plan has been completed. This means you will also not be able to pre-enroll in any classes or sign up for any of FLOAT's added value options until that registration is complete.
4. You may choose to complete the payment plan in less than the five month period, but this will not reduce the price of the convention in any way. If you wish to receive a lower price to attend FLOAT 2026, you should choose to register through the singular payment system.
5. This payment plan only applies to FLOAT's academic access. Payment plans are not available for the Weekend or Jam Pass options.
6. ALL PAYMENTS INVOLVED IN THE PAYMENT PLAN MUST BE RECEIVED AND COMPLETED BY DECEMBER 1, 2025. Anyone who has not completed their payments by December 1st will be subject to cancellation.
7. In the event that you have to cancel your registration to FLOAT 2026 for any reason while engaged in this plan or even after the payments have been completed, you will be entitled to a refund of any payments made after the initial payment of \$324 US. The initial payment of \$324 as stated is NON-REFUNDABLE and will not be subject to a refund.
8. If you cancel your registration to FLOAT 2026, you will not be subject to any benefits of any kind related to the convention. By cancelling your registration, you are forfeiting all benefits and privileges regarding the convention, including but not limited to the loss of any complimentary merchandise such as event t-shirt and stuffed tote bag as well as any future discounts pertaining to returning attendees.
9. The cost of this registration fee does NOT include costs related to attending the convention, including but not limited to travel expenses, hotel room fees, added value options at the convention or any other fee outside of what is included with a standard academic registration.
10. Registrations may not be sold or transferred in any way without approval from FLOAT. This includes any partial payments made towards the payment plan. This means you cannot transfer your partial payments to someone else in the event you have to cancel without approval from FLOAT.
